

GAS RATES TO CHANGE

Based on recent Pennsylvania Public Utility Commission (PUC) actions, changes will affect your monthly gas bill. For a residential customer using 80 cubic feet (Ccf) per month, the effect of these approved changes is a total increase of \$7.10 to the typical monthly bill, from \$70.37 to \$77.47, or 10.09%. For a commercial customer using 400 Ccf per month, the bill will increase by \$7.91, from \$323.98 to \$331.89, or 2.44%.

The enclosed bill reflects these changes. Here are the details:

Distribution Charges: The PUC has granted PECO a \$29.1 million rate increase to its delivery service charges. Effective with bills issued on July 13, 2021, this change results in a \$7.43 increase in Distribution Charges (including the Customer Charge) on the monthly bill for a typical residential customer using 80 Ccf of gas per month and a \$8.91 increase in Distribution Charges (including the Customer Charge) on the monthly bill for a commercial customer using 400 Ccf per month.

Purchased Gas Cost (PGC): The Natural Gas Supply Charge (included in the PGC) changes as a result of the updated Gas Procurement Charge (GPC) and Merchant Function Charge (MFC). The Natural Gas Supply Charge will decrease from \$0.35932/Ccf to \$0.35529/Ccf for a residential customer and from \$0.35659/Ccf to \$0.35409/Ccf for a commercial customer. This change results in a \$0.33 decrease on the monthly bill for a typical residential customer using 80 Ccf of gas per month and a \$1.00 decrease on the monthly bill for a commercial customer using 400 Ccf per month.
