## Understanding Your 2020 Electric Rates And How To Calculate Your Bill.

PECO is providing you, our residential customer, some basic information on how to calculate your unbundled electric bill. The two residential rate choices that are available to you are Residential Service (Rate R) and Residential Heating Service (Rate RH). A sample calculation of each rate is enclosed in this pamphlet. You can find out what type of service you currently have by looking just below the **Meter Information** on page 2 of your electric bill. **For Rate RH, Winter Months are October through May, Summer Months are June through September.**

## Residential Service – Rate R 2020 Electric Rates

This service is available to single, private homes, or, in certain cases, a building that has up to five dwelling units. Service is supplied through one meter.

## Residential Heating Service – Rate RH 2020 Electric Rates

This service is available to single, private homes, or, in certain cases, a building that has up to five dwelling units. Service is supplied through one meter and the home must be heated by a qualified electric space heating system.
